The Conference was co-sponsored by the Pacific Regional Educational Laboratory (PREL) whose board of directors held one of their three annual board meetings simultaneously with the Pacific Education Conference.

The Opening Ceremony on August 6, 1996, began with an Invocation by Rev. Rensper Jack, welcoming remarks from Secretary of the FSM Department of Education and from Pohnpei Governor Del Pangelinan, followed by conference remarks from Dr. John Kofel, Executive Director of PREL. A Teacher of the Year Recognition award was presented Dr. Rita Hocog-Inos, Deputy Director, PREL, culminating the opening ceremony.

Hosting the Conference was Pohnpei State Department of Education with the assistance of the FSM Education Department. More than 1,000 participants from American Samoa, Commonwealth of the Northern Mariana Islands, Guam, Hawai'i, Republic of the Marshall Islands, the Republic of Palau and the Federated States of Micronesia's states of Yap, Chuuk, Kosrae and Pohnpei attended the Conference. Educators from US mainland, Australia, Vanuatu and Cook Islands also attended.

During the Conference more than 100 workshops were held and presentations made by invited guests on a wide range of topics including classroom techniques, parent involvement in the educational process, politics, economy, family planning, and culture, to name a few. Cultural nights provided opportunities for sharing of dances and songs, gift giving, and broadening one's cultural understanding, friendship and professional relationships.

The Conference provided participants and their hosts an excellent opportunity to sample the various aspects of local custom and culture, the way of life in Pohnpei State, which the participants will long remember.

Ambassador Moses who was born Aug. 31, 1944, in U municipality, Pohnpei, began his service as a laborer for the then Ponape District in 1963. He served as Student Services Coordinator at the Trust Territory Department of Education from 1968-69, and became a high school teacher at PICS in 1970. He also served as Instructor at the Community College of Micronesia (CCM) in 1971, and from 1973-76 he was a Representative in the Congress of Micronesia. After serving in the Congress, he was District Administrator school-to-work programs. Since its inception in Guam in 1984, the conference, in addition to the growing professionalism of Pacific educators, has developed a unique flavor that sets it apart from other conferences: The Pacific Way. Among traditions at this conference are sharing in songs and dances, gift giving, and speaking that expand learning into the realm of understanding.

During his years of study, he was awarded fellowships and scholarships to pursue his studies.

The maps shows the sea floor topography of the FSM's Exclusive Economic Zone in the State of Yap. It revealed the presence of a number of seamounts which were previously unknown and an interesting discovery that the deepest spot on earth in the world reknowned Marianas Trench, is indeed within the EEZ of the FSM, says Acting Secretary of External Affairs Lorin Robert. The project was funded by the Government of France at the request of the FSM Government.

A luncheon was hosted by the Acting Secretary at PCR restaurant in honor of Ambassador Frasseto and the company officials who undertook the project.

In a related development, Ambassador Jean Bressot of France to the South Pacific Commission (SPC) was here at the same time. He and Ambassador Frasseto called on Vice President Jacob Nena on the 19th of July.

## 4 Pohnpei team wins Law Day Debate held in the State of Chuuk

PALIKIR, Pohnpei (FSM INFORMATION SERVICE) - The 1996 Law Day Championship High School debate was held at the FSM Supreme Court in Chuuk on July 12, (FSM National Law Day), on the topic: Resolved that testing for Human immuno-deficiency virus (AIDS) should be required of all persons over the age of 16 years seeking entry or reentry into the FSM.

The topic was selected to reiterate the potential danger of contacting AIDS and the need to prevent it from spreading into the FSM.

Four FSM high school debating teams represented their respective States at the initial Semi-finals.

The Kosrae team composed of Marmine S. Robert and Rigsby Robert, both from Kosrae High School, proponent of the topic was subdued by the Chuuk team of Susan Lowe from Xavier High School and Arrol Suda from Chuuk High School, opponent of the topic, 338 points for Kosrae and 390 points Chuuk debaters.

In the second semi-final, Pohnpei's team composed of Dahlia Johnson and Kenye Sigrah, both from Calvery Baptist Academy, proponent of the topic, won with 388 points over the Yap's team composed of Vera Layan and Tony Terag, Jr., both from Yap High School with 284 points. In the final match between Pohnpei's team who retained their position as a proponent of the topic won over the Chuuk's team who retained their position as opponent of the topic. Pohnpei's team won with 379 points over the Chuuk's team with a close of 368 points. The debating teams from Kosrae and Yap States were tied for the third place.

The FSM Law Day program began with the Flag Raising while the National Anthem was sung by the Pentecostal Lighthouse Youth Choir, followed by an Invocation by Fr. Julio Angkel. FSM's Supreme Court Acting Chief Justice, Richard H. Benson, presented the opening remarks while Chuuk State Chief Justice Souckichi Fritz gave the welcoming remarks and the Keynote Address was given by Congress Speaker Jack Fritz. Benediction was given by Rev. Harvey Daides and the Master of Ceremonies was Public Defender's Representative based on Kosrae Joses R. Gallen, who is a member of the 1996 FSM Law Day Committee.

This year's debate judges included the FSM Attorney General, Camillo Noket, Esquire; Professor Alvios J. William, University of Guam; Captain Douglas Hammer, US Air Force's Civic Action Team in Chuuk; Chuuk Peace Corps Volunteer Harry Goon; Dr. Steven Winter, Chuuk State Hospital and Rev. Edgar Isaac, Assistant Administrative Officer, FSM Congress.

Coaching the 1996 debating teams were Skipper Ittu, coach for Kosrae's Team; Paul and Andrea Milner, for the Pohnpei Team; Phil Chavez, Yap's Team Coach; and Retis Heldart for Chuuk's Team.

It was estimated that nearly a thousand spectators attended the opening ceremony outside the Supreme Court Room and inside the Court Room where the debate was held. Those who

surrounded the Court Room watched the debates on a television monitor setup by the FSM PIO TV-Cameraman, Elieser Rospel, who was on hand to record on video tape the debates. His trip was made possible by FSM Health Services and FSM Supreme Court.

The ceremony and the championship debate were broadcast live via satellite connection from FSM Telecom to the FSM States and relayed by radio stations in Pohnpei, Chuuk, Yap and Kosrae.

Because the democratic, constitutional and legal institutions of the FSM provide lasting benefits to the citizens and residents of the FSM, it should be suitably commemorated, h t e proclamation stated.

# COM-FSM trying to raise \$250 grand by Vice President issues March 1997 for endowment fund

Pohnpei PALIKIR, (FSM **INFORMATION SERVICE)** - The College of Micronesia -Federated States of Micronesia (COM-FSM) is trying to raise \$250,000 by March 1997, and has asked the National Women's Council to help raise that amount in a July 8, 1996 letter addressed to Chairperson, Mercedes Santos, from COM-FSM President, Susan Moses.

The funds raised will match the \$500,000, grant reservation for which COM-FSM has applied successfully under a Endowment Challenge Grant Program authorized by Title III of the Higher Education Act of 1965, as amended, from U.S. Department of Education.

For every dollar raised by COM-FSM, U.S. Department of Education will match it with two dollars.

This is part of COM-FSM's long range mission to build the principle of this fund to somewhere between \$10-\$20 million at which point the College would use the annual interest earned on this fund to support programs for its students. Moses stated that the College has pledged not to use the principle from the fund for at least 10 years to allow growth.

COM-FSM's immediate mission is to

provide an equal opportunity for a quality higher education; assist with the job training needs of the nation; promote economic development; foster a sense of national unity; preserve and enhance the artistic and cultural heritage of the community; encourage growth of the individual as a person, as a citizen of his/her community, nation and the world, and as an enthusiastic and competent participant in his or her civilization and culture, Moses further stated.

Moses stated that COM-FSM will give permanent recognition to contributors by showing on the wall of the new administration building in Palikir campus as follows: Bronze Circle for \$100 to \$999; Silver Circle for \$1000 to \$9,999; Gold Circle for \$10,000 to \$24,000; Platinum Circle for \$25,000 to \$99,999; and Platinum Elite Circle for \$100,000 and over contributions.

COM-FSM has raised \$37,000 with the help of numerous fund raisers since the drive kick-off dinner and is continuing the drive with food sales by students and staff, formation of an« Alumni Association, car washes, a matha-thon and "supersale."

Moses concluded by soliciting everyone to support COM-FSM through their contributions.

Available also at the International Law Fellowship Program for mid-level government legal officers and young teachers of international law are training programs to deepen knowledge of international law; provide opportunity for frank and informal exchanges of views and increase practical experience of legal work at the United Nations and its agencies.

Fellowships are also available at the Hamilton Shirley Amerasinghe Memorial Fellowship on the Law of the Sea, dealing with post-graduate level research, study and training in law of the sea and related marine affairs. Candidates must demonstrate advanced study capacity. Offers are available at various institutions in Geneva, Canada, United Kingdom, Netherlands and the United States.

Finally, a fellowship for young lawyers, government officials, judges and arbitrators in International Trade Law, focuses on uniform commercial law. Interested individuals should contact their State Governor's Office.

## Olter suggests Pohnpei State pay its credit to be able to get needed medication

PALIKIR, Pohnpei (FSM INFORMATION SERVICE) -President Bailey Olter on June 21, 1996 informed Governor Del Pangelinan that Pohnpei State Government needs to allocate \$330,000, in order for the Director of Health and Human Services Supply Service Center in Perry Point, Maryland, to restore her credibility and purchasing power or reputation to be restore.

Pohnpei must also recognize its debt of nearly a quarter of a million dollars, and enter into a binding agreement on retiring the balance of the debt. Consequently, Pohnpei will be able to resume cash on delivery (C.O.D.) purchase basis.

Olter stated that review by the FSM Department of Health Services revealed that there is \$230,000 worth of unhonored requisitions for medical supplies with the company in Perry Point which cannot be filled because of Pohnpei's debt.

Olter said that he is optimistic about restoring Pohnpei's ability to resume purchase of medical supplies from the company if Pohnpei will agree with his suggested way of retiring previous debts and getting new medicine Pohnpei hospital now badly need.

# Conference on Special Education and Children with special needs held in Pohnpei

PALIKIR, Pohnpei (FSM INFORMATION SERVICE) - A jointleadership conference on Special Education and children with special needs was held in Pohnpei, May 14 to 15, 1996, participants of which included the Secretaries of Education and Health Services Departments from the FSM National Government and their counterparts from the states and their staffs.

The purpose of the conference was to increase the opportunities for collaboration between service providers to special needs children and their families in the FSM, pursuant to FSM Public Law No. 8-21 and US Public Law No. 104-134. Funding in the amount of \$4 million is readily available for 1996 and 1997 operations and has been divided among the four States according to a FSM's formula which the U.S. Department of Education follows in allocation of states' shares. The formula calls for an equal distribution of 50 percent of the money among the four states; 30 percent is to be distributed based on the number of handicapped children reported in each state; and 20 percent is based on the total school enrollment in each state. Because each state is responsible for supplying these data, a Joint Interagency Agreement designed to promote collaboration and cooperation between the departments of Education and Health Services at the national and the state levels will enhance implementation of Special Education and related programs in the FSM.

The conference was jointly sponsored by the FSM Departments of Education and Health Services with consultants from the Universities of Guam and Hawaii, the University Affiliated Programs and the Western Regional Resource Center.

All participants from the states and the national government, agreed that there is a need for collaboration and cooperation between departments and agencies including Special Education, Maternal and Child Health (MCH), Headstart, and the College of Micronesia-FSM, who deal with special needs children and their families.

As a result, the Secretaries of Education and Health Services of the National Government and State representatives signed a Memorandum of Understanding (MOU) at the end of the conference which enumerates the responsibilities of the respective departments at the national and state levels. The MOU also reiterated their commitments for improved services through team work.

Secretary Catalino Cantero of the Department of Education and Secretary Eliuel Pretrick of the Department of Health Services stated cooperation between all of the education and health departments will maximize services to children with special needs and their families and that at this critical time all must work together.

The conference documents showed that funding in 1996 available for Special Education Program in FSM increased to more than \$3 million, proposed distribution among the states in dollar amount are as follow: \$620,000 for Kosrae; \$590,000 for Yap; \$1.2 million for Pohnpei; and \$1.3 million for Chuuk, according to FSM Special Education Coordinator Makir Keller.

## **CPAFFC invites FSM to China**

Vice President Jacob Nena informed the State Governors in July of an invitation the FSM received through the Chinese Embassy in Kolonia from the Chinese People's Association for Friendship with Foreign Countries (CPAFFC) for a State Leadership Delegation from the FSM to make a friendly visit to China at the beginning of September of this year.

Nena says that information about the trip is being gathered. Meanwhile, he asked the Governors to confirm if their states will participate in the proposed visit which will be composed of a six to eight member delegation including governors and Legislature speakers.

The CPAFFC will bear all expenses for board, lodging, and transportation in China.

## Public Auditor informed Olter he is auditing National Government travels

PALIKIR, Pohnpei (FSM INFORMATION SERVICE) - The new National Public Auditor Rensly Sigrah, told President Bailey Olter that his office is conducting an audit of the National Government travel activities to determine whether applicable policies and guidelines are followed. Sigrah's letter dated June 20, 1996, stated that the purpose of the audit is to determine whether or not the Travel Authorizations (TAs) are consistent with the Financial Management Regulations.

One of the requirements is that a traveler must submit a report on the purpose of the trip, what was accomplished, and recommendations to the Government for future action. In this connection, the Office of National Public Auditor requested copies of randomly selected trip reports taken by staff in the President's office before July 5, 1995, to be forwarded to his office for review. 7

# Descendant of Captain O'Keefe attend opening of O'keefe Kanteen

COLONIA, Pohnpei (FSM INFORMATION SERVICE) - A big crowd including local dignitaries gathered at the Yap International Airport on August 7 to welcome the arrival of a descendant of Captain David Dean O'Keefe to Yap, according to Youth and Civic Affairs Information Officer Willy Gorongfel.

Charles O'Keefe Butler and his wife Janet were accompanied by Bruce L. Campbell of the Pacific Daily News, a member of the Gannett group of newspapers, and the stringer for the New York Times. Charles O'keefe Butler is the great grandson of Captain O'keefe.

The Butler's family visit to Yap was organized by Donald Evans, operator of the Ethnic Art Institute and the Eco-Tours in Yap to Coincide with the opening of the O'Keefe Kanteen in Colonia. The O'Keefe Kanteen is built at the same place where Captain O'Keefe has his Kanteen in the 1800's.

The O'Keefe's family traveled from Savannah, Georgia to Yap to participate in the historic re-opening of Captain David Dean O'Keefe's Kanteen, August 9 which include the leadership of the State of Yap.

A presentation of a proclamation by Mayor Floyd Adams, Jr. of Savannah as "Yap Week" in honor of the historic relationship between the city and Yap.

Governor Figir on August 5 issued a similar proclamation establishing that August 9 of each year shall be observed as Captain David Dean O'Keefe Day in Yap State in commemoration of Captain O'Keefe and his contribution to the culture and history of the people of Yap.

The opening ceremony of the O'Keefe Kanteen on August 9 include remarks by Governor Figir, Speaker Robert Ruecho' and Chief Andrew Ruepong.

#### Olter appoints Governor and alternate Governor to ADB

PALIKIR, Pohnpei (FSM INFORMATION SERVICE) - FSM President Bailey Olter in June informed the Asian Development Bank President Mitsuo Saito, of the appointment of John Ehsa, Finance Secretary as Governor, and Assistant Secretary of External Affairs Lorin Robert, as Alternate Governor of the ADB, pursuant to Article 27 of the Articles of Agreement.

In a related activity, President Olter in a diplomatic communication to the President of the International Bank for Reconstruction and Development appointed also Ehsa and Resources and Development Secretary Sebastian Anefal, as Governor and Alternate Governor, respectively. All appointments took effect June 12, 1996.

Ehsa was appointed by virtue of his position, ADB Alternate Governor Lorin Robert has held this capacity for which he was reappointed and appointment of Anefal was by virtue of his position.

The FSM became a member of the ADB mid 1990. To date, the benefits to the FSM from its membership include various annual technical and economic policy advisory missions fielded by ADB to the FSM and the potential for long-term, low interest soft loan including the already approved \$6.5 million fisheries development loan and the proposed \$12 million water resource development project for the FSM.

The village of Maa,' Tomil presented a traditional dance during the opening. Charles Butler presented an oil painting portrait of Captain O'Keefe for instalation in the Kanteen.

Donald Evans, organizer of the event, presented a statement of gratitude and Father Fran Hezel, an authority on Micronesian history, also delivered at the closing remarks. Captain O'Keefe's flag was unfurled and his Kanteen was officially opened.

Captain O'Keefe married Catherine Masters of Savannah and started a family there before he left the city aboard the Belvedere. He became the sole survivor of a ship wreck on the Belvedere and washed up on the reef on Southern Yap in 1871. He was nursed back to health by a magician from Dulkan village.

O'Keefe, known to the Yapese only as "His Majesty" established his home on Tarang Island in the Tomil Harbor. The island is known today as O'Keefe Island.

The secret of O'Keefe success in dealing with the Yapese was his recognition that the key to trade with them was a traditional, not modern commodity. He helped the Yapese in quarrying and transporting the highly valued stone money from Palau to Yap in exchange for copra. He skillfully built alliances with Yapese chiefs, respected customs, and developed a reputation as one who always dealt fairly and above-board with the local people.

Because of this relationship, he built an empire which dominated the copra market in the region.

Captain O'Keefe disappeared at sea in 1901 - probably the victim of a typhoon.
